教學目標 Course Objectives:

The term "governance" has become a concept that is widely used in various fields related to public affairs. Distinguishing it from the concept of governing, governance incorporates the roles of other sectors and organizations beyond a government when tackling public problems. Despite its importance, government is considered as only one of the actors that have influence on public policy. Government needs to collaborate with other actors during the policy process. This course aims to introduce the concept of governance, which is expected to provide a theoretical perspective for students who study the urban development of cities. Several issues related to governance, such as the goals of governance and governance mechanisms, are also discussed.

內容綱要 Course Outline:

The first part is the introduction of various forms and ways of governance. Global governance becomes a trend as international interaction increases, while localization calls attention in expressing unique competitiveness. Network governance incorporates governments at all levels, business and the third sectors to accomplish cohesive tasks. The second part discusses how government chooses among the approaches of governance and policies. The final part explores how government can help economic development. We adopt the economic and philosophical approach and ask whether government should intervene in individual choices and free markets.
